GMB Scotland fully supports Monica Lennon's proposal for a Sanitary Products (Free Provision) (Scotland)

Our support follows consideration and discussion of the issues raised in Ms Lennon's consultation by the GMB Scotland Women's Conference.

Our activists and representatives have argued in support of the proposal drawing on their experience representing thousands of women in workplaces all over Scotland. GMB Scotland believes that access to sanitary protection should be seen as a right. Women do not have a choice over whether they have a period, appropriate products should not therefore by only a commodity. They are essential for good health, hygiene and human dignity.

Women and girls should not have to go without sanitary products because of costs and the proposed bill and the associated publicity associated with the introduction of a scheme will provide an option for free products which can be accessed by those who need them. The proposal to address period poverty will, we hope also, open up a debate about other issues affecting women in the workplace including women experience menopause, a subject about which GMB Scotland women have also been campaigning.

We would also hope that employers not explicitly covered by the bill's proposals will follow the lead which has been shown by some in making sanitary products available for free in more and more workplaces. GMB Scotland commends Monica Lennon for bringing forward these proposals and hope other Members of the Scottish Parliament will support the bill.
