I support young people in a primary school and their parents. We are aware that a number of our girls around P6 & 7 are often absent when they have their periods. When discussing attendance with parents, they often note that periods are the reason for absence. Many of the young girls live in SIMD 1&2 and we support these families around finances and benefit difficulties. We operate an eco project where food which would be sent to landfill is provided to our families. As part of this project we also supply hygiene packs to women which includes deodorant and sanitary products. Since we have provided these products, we have had more parents asking for these products and openly discussing how expensive they are and how they appreciate that our school has been pro-active in supporting this hidden cost. Some of our pupils have spoken about being absent as they have been worried about not having supplies of towels.
